QUALIFYING PROCEDURE

Starting positions 1st thru 26th will be assigned by order of qualifying time. Positions 27 and 28 will be provisional positions, one (1) for SELLM top 20 points and one (1) for Hickory Motor Speedway top 10 points for competitors not otherwise qualified on time through time trials or qualifying heat. If qualifying for the event on Saturday, October 16, 2010 cannot be completed as scheduled due to unforeseen circumstances and is not rescheduled, the starting field for the RidersWholeSale.com 150-Lap Limited Late Model Event will be determined by the following procedures:

1. Starting positions 1st thru 26th will be assigned by the postmarked date on the entries received.
2. Starting positions 27th and 28th will be assigned by track provisional positions selected by the SELLM Series and Hickory Motor Speedway.

The decision of what constitutes an official qualifying attempt or official practice attempt shall be at the discretion of the Track Official in charge of the event.

If duplicate qualifying times are recorded, the first car to qualify in the qualifying order will be awarded the qualifying position.

A qualifying race will be held in the event of 30 or more entries. Top 16 will be lock positions through time. Positions 17-26 will set through 25-lap qualifier. Positions 27 and 28 will remain provisional positions.

SLLMS TIRE RULE

All cars must run Goodyear D-2902. Tires used in practice, qualifying and the race must be purchased and mounted at the track and will be impounded. Drivers can purchase 4 new tires for \$546.

NOTE: Practice tires will be available Friday and Saturday.

TRACK FUEL RULE

All cars must use Sunoco Purple Fuel (110) purchased at the track – 10 gallons @ \$7.75/gallon. Fuel must be used exactly as supplied by fuel dispensing equipment at the track.

**SPECIAL RULES:
ELIGIBILITY REQUIREMENTS**

This event will be run in accordance with the applicable Southeast Limited Late Model rules as presented in the 2010 Southeast Limited Late Model Series Rules and the provisions of the Official Entry Blank. In the event of any conflict between the Rule Book, the Official Entry Blank and the special rules, Series Officials will determine the interpretation and application of the conflicting rules and their decision will be final.

NOTE: The Promoter reserves the right to make necessary changes in the schedule due to unforeseen circumstances such as, but not limited to, weather.
