### **DISTRIBUTION:**

1<sup>st</sup>: \$4,000 2<sup>nd</sup>: \$1,750 3<sup>rd</sup>: \$1,000 4<sup>th</sup>: \$800 5<sup>th</sup>: \$700 6<sup>th</sup>: \$650 7<sup>th</sup>: \$600 8<sup>th</sup>: \$550 9<sup>th</sup>: \$500 10<sup>th</sup>:  
\$450 11<sup>th</sup>: \$400 12<sup>th</sup>: \$375 13<sup>th</sup>: \$350 14<sup>th</sup>: \$325 15<sup>th</sup>: \$300 16<sup>th</sup> thru 32<sup>nd</sup> \$250 each. All drivers  
must attempt to qualify for this Event. The decision of what constitutes a qualifying attempt shall  
be at the discretion of the track Officials in charge of the Event.

---

### **QUALIFYING:**

Qualifying will be determined by the better of 2 timed qualifying laps, If for any reason qualifying  
cannot be completed starting lineup will be determined by practice times in the first round of  
practice on race day. In the event that practice and qualifying is not completed starting lineup will  
be determined by date entries are received with the earliest being the pole.

---

### **RACE PROCEDURE:**

This race will be run in two segments of 100 laps each with a 10 minute break which competitors  
will be allowed to change two tires from the impound area at the halfway point. Caution laps will  
be counted. Last 20 laps will be under green. Lucky Dog rule will be in effect for this event. Any  
car involved in the caution will not be eligible for the Lucky Dog award.

---

### **TRACK TIRE RULE:**

All cars must run Hoosier F-45s. Tires used for qualifying and the race must be purchased and  
mounted at the track and will be impounded. Cars will be required to qualify in time trials on new  
sticker tires and start the race on the same tires. Maximum of six (6) Hoosier F-45 sticker racing  
tires for the race.

NOTE: Practice tires and fuel will be available Friday and Saturday.

---

**TRACK FUEL RULE:**

All cars must use Sunoco Purple Fuel (110) purchased at the track. Fuel must be used exactly as supplied by fuel dispensing equipment at the track. All cars must purchase 20 gallons per car for this event.

---

**SPECIAL RULES – ELIGIBILITY REQUIREMENTS:**

This Event will be run in accordance with the applicable NASCAR rules as presented in the 2020 NASCAR Advance Auto Parts Late Model Stock Division Rule Book, and the 2020 Hickory Motor Speedway Rule Book. In the event of any conflict between the Rule Books, or the Official Entry Blank, the track Officials will determine the interpretation and application of the conflicting rules and their decision will be final. Crate motors are eligible: see track rules at [www.hickorymotorspeedway.com](http://www.hickorymotorspeedway.com) for specifications.

Transponder scoring will be used and transponders will be available at sign in.

Each Team must have a spotter during practice, qualifying and the 200-Lap Feature. All spotters are required to have radio contact with the driver. It is recommended that the pit crew also have a radio scanner to monitor the track frequency. The frequency being used will be made available at the pit gate and the tech shed.

**This will be a NASCAR Sanctioned event for NASCAR Advance Auto Parts Late Models.**

**NOTE: The Promoter reserves the right to make necessary changes in the schedule due to unforeseen circumstances such as, but not limited to, weather.**
