DISTRIBUTION:

1st: \$1,500 2nd: \$800 3rd: \$600 4th: \$400 5th: \$300 6th: thru 32nd \$250 each. All drivers must attempt to qualify for this Event. The decision of what constitutes a qualifying attempt shall be at the discretion of the NASCAR Officials in charge of the Event.

NOTE: Hickory Motor Speedway track points will be awarded for this Event.

RACE PROCEDURE:

This race will be run in one segment. Caution laps will not be counted.

TRACK TIRE RULE:

All cars must will purchase qty-4 sticker Hoosier F-45s held in impound at the track.

Tires can be purchased and mounted on Friday September 4th as long as the wheels are present.

NOTE: Sticker Practice tires and Scuffs will be available.

TRACK FUEL RULE:

All cars must use Sunoco Purple Fuel (110) purchased at the track. Fuel must be used exactly as supplied by fuel dispensing equipment at the track. All cars must purchase 10 gallons per car for this event.

SPECIAL RULES – ELIGIBILITY REQUIREMENTS:

In the event of rain starting positions will be determined by first practice times, in the event that practice would be rained out starting positions will be determined by entry submission. Date/Time

This Event will be run in accordance with the applicable NASCAR rules as presented in the 2027 Hickory Motor Speedway Rule Book. In the event of any conflict between the Rule Books, or the Official Entry Blank, the track Officials will determine the interpretation and application of the conflicting rules and their decision will be final. Crate motors are eligible: see track rules at www.hickorymotorspeedway.com for specifications.

Transponder scoring will be used and will be available at sign in.

Each Team must have a spotter during practice, qualifying and the 50-Lap Feature. All spotters are required to have radio contact with the driver. It is recommended that the pit crew also have a radio scanner to monitor the Hickory Motor Speedway frequency. The frequency being used will be made available at the pit gate and the tech shed.

NOTE: The Promoter reserves the right to make necessary changes in the schedule due to unforeseen circumstances such as, but not limited to, weather.
